REFER A FRIEND ("RAF") Terms and Conditions

THIS AGREEMENT is made on the Agreement Commencement Date,

BETWEEN:

- (1) The **Refer a Friend** referrer ("**RAF**"); and
- (2) **AHOY CLUB LIMITED**, ("**Ahoy**");

- 1 Refer Ahoy Club to your friends! If your friend enters your Ahoy Referrer Code in the Ahoy Referrer Code box when they book and complete their charter you will (subject to these terms and conditions) receive a RAF Bonus.
- 2 A RAF Referrer Code cannot be used in conjunction with any other promotions or referrer codes.
- 3 The term of this Agreement is 12 months from the commencement date.
- 4 Your "**Friend**" is a person (whether a natural person or a body corporate) that you introduce to the Ahoy Club.
- 5 A "**RAF Bonus**" is a credit of \$250 (in the currency of the region the charter is being either €, \$USD or \$AUD) to your Ahoy Club account A RAF Bonus is only payable in respect of the first booking of a Friend who has not previously booked a charter with Ahoy Club and is subject to receipt by the Ahoy Club of cleared funds in respect of all and any fees and charges due in relation to that booking.
- 6 A RAF Bonus is not payable unless the Ahoy Referrer Code is entered at the time of booking.
- 7 The RAF Bonus can only be redeemed or exchanged for cash for those entities approved by Ahoy Club at the time of signing this agreement and where the "Cash Redeemable" box is clearly filled in as YES.
- 8 The RAF bonus offer is valid for a period of 120 days from the date the friend joins the Ahoy Club.
- 9 Without prejudice to any other remedy available to it in law the Ahoy Club reserves the right to terminate this agreement withdraw your membership and close your account(s) if it concludes at any time in its sole discretion that you or the Friend you have referred have behaved in a fraudulent manner or have acted contrary to the express terms or spirit of this agreement by opening multiple accounts for the sole purpose of securing one or more RAF Bonuses or Gold Partner Awards.
- 10 The Ahoy Club reserves the right to cancel the Refer a Friend program or to change its terms and conditions at any time in its sole discretion.
- 11 This Agreement and any dispute or claim arising out of, or in connection with, it, its subject matter or formation (including non-contractual disputes or claims) shall be governed by, and construed in accordance with, the laws of England and Wales.
- 12 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of, or in connection with, this Agreement, its subject matter or formation (including non-contractual disputes or claims).
